## OAKHORSE RANCH RELEASE OF LIABILITY

I hereby acknowledge that I have voluntarily applied to participate in lessons with Oakhorse Ranch. I am aware and agree that being around horses is dangerous and hazardous, involving risk of serious injury or death, and am voluntarily participating in these activities with knowledge of the danger involved and hereby agree to accept any and all risks of injury, death, or property damage. In consideration of being permitted to participate in these equestrian lessons and/or for the use, today and on all future dates of their property, facilities, and services, I agree that I hereby release, waive, discharge and covenant not to sue Oakhorse Ranch, its agents, representatives, successors and assigns, individually or collectively (hereafter all of the released individuals or entities are referred to as Oakhorse Ranch) for injury damage resulting from the negligence, acts, representations, or omissions, however caused, of Oakhorse Ranch as a result of my participation in these lessons and/or using their facilities, services and being on their property. In addition, I hereby release and discharge Oakhorse Ranch from all actions, claims, or demands I, my heirs, distributees, guardians, legal representatives, or assigns may now have or may hereafter have for injury or damage resulting from my participation in the lessons and/or being on their property.

As further consideration I hereby agree to indemnify and save and hold harmless Oakhorse Ranch from any loss, liability, damage, or cost that it may incur in the event of injury or damage to me while participating in the equestrian lessons and/or being on their property. Specifically, I agree to pay and indemnify Oakhorse Ranch for any claims that they must pay, and attorney's fees and costs they must incur, as a result of indemnification through a cross-complaint or subsequent complaint, or a subrogation action by my insurance company or the insurance company of somebody else, or otherwise as a result of any claim by me against any person or entity other than Oakhorse Ranch and releases for injury or damage sustained by me while participating in the lessons and/or being on their property. I hereby assume full responsibility for and risk of bodily injury, death, or property damage to me or my horse caused by the negligence of Oakhorse Ranch or otherwise while participating in the lessons and/or being on their property.

I further expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State in which the event is conducted and that if any portion, clause or subclause hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and legal effect.

I have read and voluntarily sign the release and waiver of liability and indemnity agreement, and further agree that no oral representations, statements, or inducements apart from the foregoing written agreement have been made.

## Summer Camp Rules

1. All participants must bring all required items stated on the “What to Bring” list.
2. No fighting with or bullying other riders. Any unsportsmanlike conduct will result in losing your riding time for the day.
2. ASTM/SEI approved riding helmets must be worn at all times while mounted at Oakhorse – with the exception of special vaulting sessions.
3. No sneakers while mounted, proper footwear with a heel is required – with the exception of special vaulting sessions.
4. No smoking anywhere in the barn area or near hay storage at any time.
5. An information and release of liability waiver must be filled out and signed by anyone riding at Oakhorse before riding for the first time.
6. Any person that will be in the stable area for any amount of time also needs to fill out a release of liability waiver.
7. No running, screaming, or “horseplay” anywhere in the stable or riding areas.
8. Riders are required to carry their own medical insurance.

## What to Bring:

*Please Label Everything with Name!*

1. Long pants or riding pants
2. Boots and/or shoes that are hard soled and have a low heel. Paddock boots are suggested. (They may be purchased new or used at some area tack shops)
3. Properly fitting, ASTM/SEI certified helmet (these cost as little as \$35). We have a limited number of lesson helmets available to borrow. Please enclose a note with your forms if you will need to borrow a helmet. There will be a \$15 helmet usage deposit required which will be returned to you at the week’s end provided the helmet is returned and undamaged.
4. Sneakers and a change of clothes for after riding.
5. Sweater or jacket for cool weather
6. Bathing suit for swimming
7. Towel
8. Sunscreen
9. Refillable water bottle with a top/cover
